How we get the personal information and why we have it

- To participate in competitions and activities run by the Scotland Korfball Association

How we store your personal information

Your information is securely stored in a password protected database. Only current SKA committee and advisory board members have access. The password is changed annually.

The SKA keeps:

- contact information (email address) for five years after you were last active. We will then dispose your information by permanently deleting your contact information.
- your personal information (gender) for five years after you were last active. We will then dispose your information by permanently deleting your personal information.
- your personal information (date of birth) for five years after you were last active. We will then dispose your information by permanently deleting your personal information.
- name, affiliated club(s) and korfball playing history indefinitely for the purposes of historical record keeping. If you wish for your data to be anonymised or deleted, please make a request.

Your data protection rights

Under data protection law, you have rights including:

- Your right of access You have the right to ask us for copies of your personal information.
- Your right to rectification You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.
- Your right to erasure You have the right to ask us to erase your personal information in certain circumstances.
- Your right to restriction of processing You have the right to ask us to restrict the processing of your personal information in certain circumstances.
- Your right to object to processing You have the right to object to the processing of your personal information in certain circumstances.
